

INTRODUCTION

The County of Hawai'i is currently preparing a Master Plan for a future looking multi-modal transportation system, including the county bus system known as Hele-On. One of the Guiding Principles for the study work scope is to "engage the community and stakeholders through public workshops and presentations to establish consensus and broad support for a transportation system."

A Draft Transit Master Plan was distributed and posted on the website starting February 1, 2018. A three month comment period was provided through April 30, 2018. Part One of this report contains the 18 comments posted on the project website or received by email and mail. These are shown in a matrix.

Part Two and Three of this report comprises the feedback, comments, and other input received during the second round of public comment period that included a series of six public meetings and comments received on a website. All personal information for the above has been deleted. Comments remain as they were presented, without editing.

The results of the first round of public meetings is available in a Task 3 Report which was posted on the project website and distributed to all County Council Members.


Part Two provides a side by side comparison of the six meetings, for those interested in such an overview.

W-1	3/21/2018 Website	Daniel Banks	Chapter 4 Page 50 Hakalau - highway stop	The Hakalau stop(s) on the Hilo - Honokaa/Waimea route is appreciated. Yet, in the early morning (after daylight) I've had buses pass me by. It is a situation of safety not going too far into the roadway. Rain and such are problematic for vision of both the driver and people waiting for the bus. I've had bus drivers say to 'step out more into the edge of the roadway' yet behind the white line; or to have a bright flashlight that I wave; or to wave my arms wildly in the air. I guess within reason these can work - but not a good solution overall. One suggestion is to have some type of "app" or phone contact mode so the driver will know ahead there is one or more passengers at a rural pick-up location. Then, the driver is aware to be on the lookout for one or more passengers. Of course, cell service is spotty at best at Hakalau (and other rural areas.) But, phone call or app notification could occur from the person's home. Note: I am citing page 50 just because it has the photo of the intersection at Hakalau and Chin Chuck Road to show that this pick-up point is problematic (in both directions) and why the visuals for the bus driver and roadside passengers is challenging and needs addressing. Yet at least the walkway overpass provides us rain protection.
W-2	4/11/2018 Website	Kanani laea	Full Report, Introduction ES-4 Vanpools	Please replace the paragraph with this edited version regarding vanpool- mahalo. Vanpools are another option and gaining renewed interest. Because of the many geographical pockets that are not being served by any public transportation presently, this makes Vanpooling a valuable option that certainly fills this void. Currently, Enterprise Hawaii provides a program for groups up to 15 people to form a vanpool group to share their commute to and from work. It is a turnkey program that includes the monthly rental Vanpool rate; cost of insurance (1 million); maintenance and repairs; 24-hour emergency roadside service; registration and safety check. In addition to these benefits is the fact that the Vanpool program is extremely flexible for groups who may use it for long or short term needs, without any mileage limits or restrictions. The recommendation for Vanpool is for the County to enter a two-year pilot program, subsidizing up to \$1,000 each Vanpool, per month. Total annual program cost if at capacity: \$300,000.

It is a turnkey program that includes the vehicle with the monthly Vanpool rate (plus taxes and fees) and covers the cost of insurance (1 million); maintenance and repairs; 24-hour emergency roadside service; registration and safety check.

The ADA service is priced according to Federal law. The second statement is misleading. The pricing of the ADA service is the MAXIMUM ALLOWED by Federal law, not just "riced according to Federal law." But the previous statement explains why this is so. The highest legal pricing of the ADA service is so high just in order to discourage the use of the Paratransit service. This should be admitted by a statement such as "We price the Paratransit Service as high as legally possible in order to minimize County subsidies of that service." This would be an honest description of the pricing policy.

What services are provided? We know that these services are extremely limited and available only to medical services. They are not available to disabled people generally. Why should this not be described as "Medical transportation services" or something similar? It is not a disability service.
W-7	4/15/2018 Website	Ron Amundson	Full Report Overall Missing acknowledgment	The County should (and may be legally required to) assure that transportation to the airport is available to people with mobility impairments. Until recent years there were no taxi or bus services available to the airports for people who used wheelchairs or other mobility devices. Now buses operate to the airports (after many years of advocacy) and after the recent Court settlement providing Paratransit services, taxis are available with lifts for wheelchairs. It is a responsibility of the County to assure that disabled people have some transportation options that can take them to the airports and other places in the community. This responsibility should be acknowledged in this document.
W-8	4/15/2018 Website	Martin Hodapp	Introduction Pages 7, 8 People with disabilities	As a disabled person I am pleased that the needs of the disabled community are addressed in this plan. However, I find the language used to be rather insensitive. I would suggest that disability access not be primarily phrased in terms of compliance with federal law. Other issues, such as environmental concerns, that are equally regulated by federal law, you have chosen to express as a desirable community goal. I suggest that you discuss the needs of disabled people in the same proactive spirit.

			,	While the ADA Paratransit system is included in the plan as far as how it should be expanded and utilized, there is no plan for the procurement of vehicles spelled out in the draft. Furthermore, it is not mentioned that paratransit riders are charged twice the regular fare. This is especially concerning because an increase in the base fare is anticipated. I understand that the fare essentially serves to deter abuse of the system and does not come close to covering the cost. Why charge disabled people double what the able-bodied passengers pay? The County already recognizes the limited financial means of most people with disabilities by offering a discounted fare.
				The desirability of increasing the ridership by the elderly and disabled is mentioned. One way of insuring the accessibility of the regular buses is to purchase vehicles with a low-floor design and manual fold-out ramps. Hydraulic fold-out lifts are difficult to maintain, slow and cumbersome to operate, and prone to malfunction, as I have experienced on numerous occasions on the Mainland. Finally, it is shortsighted for a 20 year plan not to consider the possibilities offered by self-
				driving vehicles. These are in operation today in some experimental markets on the Mainland, and offer potential solutions for paratransit systems.



I especially appreciate the emphasis on connectivity with cycling and other modes of transport. However, I see some holes in the logic in certain places, as well as a glaring oversight regarding North Hawaii.
				It is mentioned that bikeshare would be brought to Waimea in the near future. Before this could seem at all reasonable, it must be recognized that at least half of Waimea is, at present, quite unfriendly to cyclists. In particular, the stretch between Mana Road and Puu Nani is extremely hazardous. While we've heard that the county is currently planning to work on this stretch of road, it is not yet known whether there will be consideration of the needs of cyclists in this area. It is sad and absurd that residents of Lakeland can literally not ride their bikes the few miles into town without risking their lives. Additionally, many Waimea residents are openly hostile to cyclists and purposely threaten them with their vehicles. This is not a situation into which a bikeshare can be safely introduced: much community education needs to happen first, as well as the road improvements. Is it too much to ask to put up a few "share the road" signs? The second concern I have is what seems to be a glaring oversight regarding daily life in North Hawaii. Though the report includes Honokaa as just another one of the small plantation towns on the Hamakua coast, it is in fact a much more intact community than the rest. Additionally, Waimea and Honokaa seem in many ways to function as one extended version of the same town, albeit separated by 15 miles. I believe if a study were conducted, one would find that a large percentage of the residents of these two towns travel between them multiple times a week, if not multiple times a day. For work, school, and errands, the services that residents require are located in both towns. Honokaa has a movie theatre, while Waimea does not. Waimea has a pharmacy, which Honokaa no longer does. While students who live in Waimea and attend Honokaa school have a school bus service, none of the many schools in Waimea have any buses for students from Honokaa. The morning school route alone is a major one for all those students attending private and charter schools in Waimea. Likewise, some senior c



8) Kelly Finn, Puna

- As a resident of lower Puna, Kapahana Seaview Estates specifically, I would absolutely love to be able to take the bus in a reasonable amount of time to Hilo Airport. Currently I can accomplish this two times a day and taking more than 3 hours and having one transfer at Prince Kūhiō Plaza. In other words, it is not at all convenient. Currently I would leave Seaview at 9:10 PM to arrive at the airport at 12:00 PM, or leave Seaview at 1:50 PM to arrive at the airport at 4:00 PM. If the two buses are on time. However, I have never tried to do this because the times are not convenient. Unfortunately, typically one flies out in the morning before noon and flies in after 4:00 PM. In other words, at the time, unless you live in Keaukaha, it is pretty impossible to take the bus to the airport. We are forced to drive ourselves and pay \$15.00/day in airport parking which has become nearly cost prohibitive.
- Any other option would be if there were suitable and safe park & ride locations where one could leave their car for a few days safely and take the bus to the airport. Adding better and direct airport service would be very useful and seems to me is exactly the type of service a useful public transport system would provide.
- It would also be nice for the senior citizens in my neighborhood if the bus could come up Mapuana perhaps to the pavilion on Nahokuele Street and then back down. Mahalo nui loa.

 "call for pick-up" reservations
- Have a directory of "local mechanics on call" to help when buses break down on route, or help is needed at the maintenance facilities.
- Consider using Kona, not just Hilo, to service and maintain the buses
- Provide "service logs" on each bus
- Use "pre-cast or prefabricated" bus structures
- Create special destination buses, such as a "shopping bus" for Kona, as many Waimea residents go to Kona for Costco, Walmart,
 Target, Macy's, etc. Provide for the storage of packages, shopping bags, boxes.
- Re-think how to revise the resort bus schedule to accommodate the number of employees and buses needed at peak times to deliver employees on time for work to the hotels. Provide "express service" to the hotels, explore partnering with hotels to do so
- Review routes to ensure we are also serving main recreational facilities
- Provide information on the recommendations for "carrying school children" to public and private schools
